4. Students were fairly dissatisfied with cleanliness of washrooms.

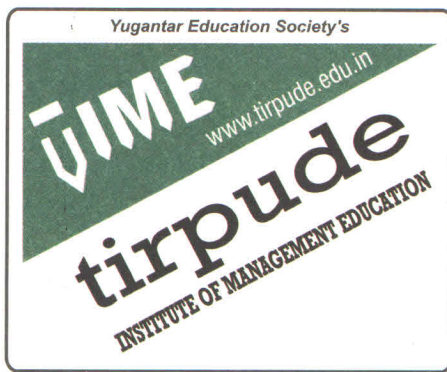
Specific Remarks:

3. Students were fairly not satisfied with canteen facilities.

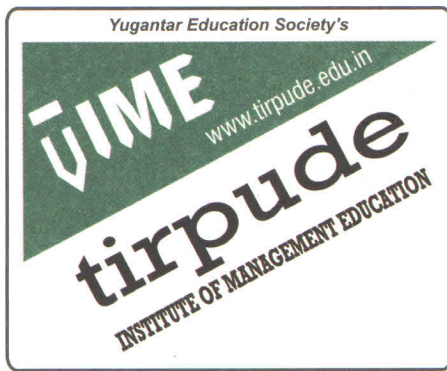
Specific remarks:

6. Alumni were satisfied with the support and help from Non-teaching staff of the Institute.

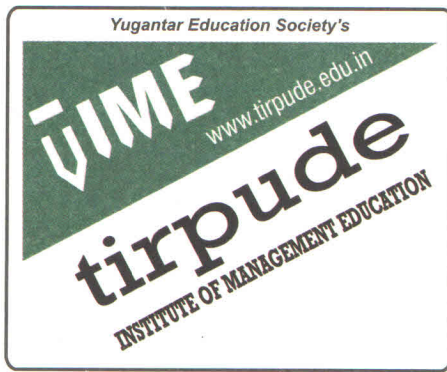
Special Remarks:
